I. Open meeting, President

- A. The Board of Directors meeting was called to order by President Dan Gillins at 16:02 Eastern.

II. Agenda

- A. Upon call for further additions, no new business was introduced.
- B. Gillins indicated that he would cover Martin's Treasurer's report and SaLIS subscription rates, based on files posted by Martin earlier August 11.
- C. The AAGS BOD agenda, posted August 10, was accepted without objection.

III. Minutes

A. No corrections were submitted to the July 09 Meeting Minutes

- IV. Review of Last Month's Action Items and Important Business
 - A. Discussion of COGO endorsement of URISA letter (Cavell)
 - 1. No further developments beyond last month's discussion.
 - B. New editor for SaLIS (Gillins/Meyer)
 - 1. Ghilani, Meyer, and Gillins have interviewed three interested candidates for the post that Ghilani is vacating.
 - 2. A decision is desired this week, and Gillins will notify board members for an online vote. *Gillins sent this notification Thursday, August 13 afternoon.*
 - 3. The new editor will be encouraged to bring others on as associate editors, spreading the workload.

V. Treasurer's Report (Martin)

- A. The Treasurer's Report was distributed by email August 11, along with SaLIS financial and subscription pricing information, and the June 2020 P&L.
 - Questions were invited, but none were raised.
- B. The board determined to leave subscription pricing unchanged for 2021. Gillins will inform Martin. Members agreed that raising prices would be counterproductive, and that lowering prices would risk sending the message that the price had been too high.
- VI. Surveying and Land Information Science
 - A. SaLIS Ex-Comm (Meyer)
 - 1. No further discussion.
 - B. SaLIS Editor (Ghilani/Gillins)
 - 1. Five articles have been accepted for the November issue, including two student papers.
 - 2. These articles have been sent to Sheridan for processing; so the November issue is done.
 - 3. One article has been accepted for the May 2021 issue, and one submission needs further work on grammar and presentation, by the author.

VII. Committees

- A. Communications (Meyer)
 - 1. Messaging to membership has been met with good feedback.
 - 2. Ghilani is to send Meyer the Table of Contents for the November issue of SaLIS, to be distributed to attract readers.
 - 3. The AAGS website has been updated, to include photos of AAGS officers. Officers whose photos have not yet been included are welcome to submit photos by email to Meyer.
- B. Membership Committee (Zilkoski)
 - 1. The July meeting was attended by Gillins, Zilkoski and Roman. All AAGS members are welcome.
 - 2. Discussion covered
 - a. ideas to get more material
 - b. potential for a newsletter
 - c. how to publish something online such as a bulletin
 - d. how digital publishing expedites the process from submission onward
 - e. inclusion of much more detailed explanatory material

- 3. Contact from Trish Milburn reported six new AAGS members, and 69 members from 2019 who did not renew in 2020.
 - 5 AAGS Fellows
 - 8 Affiliate members
 - 10 Associate members
 - 10 Full members
 - 36 Student members

Zilkoski will send the AAGS Fellows a personal email to encourage renewal.

- 4. Zilkoski noted that more members participated in the August 11 Board meeting than before, and he encouraged them to continue attending. He urges all AAGS members to consider being involved with the AAGS Board, committees, etc., and to participate in the AAGS Membership meeting two weeks after the Board meeting.
- 5. Ghilani emphasized that SaLIS accepts technical articles and reports, in addition to research.
- 6. The next Membership meeting is scheduled for Tuesday, August 25, at 4pm Eastern. Gillins sent a recurring calendar invite to the Membership GoToMeeting, to all AAGS members.
- 7. Cavell suggested that Trish Milburn could coordinate the inclusion of AAGS news blurbs in NSPS News and Views, which would deliver such content to a broader audience.

 - 1. No updates to report.
- B. COGO (Cavell)
 - 1. Every couple of years, newer COGO members suggest deprecating qualification-based selection in favor of bid only. However, COGO has set out a strong set of criteria for selecting suppliers, so the turbulence seen at this time will die away.
- C. ASPRS (Burtch)
 - 1. No updates to report.
- D. UESI (Dennis/Gillins)
 - 1. ASCE-UESI Surveying & Geomatics Conference has been postponed to April 25-27, 2021, in Lawrenceburg, Indiana.
 - 2. The national student civil engineering/surveying competition to be held June of 2021, at the NGS Testing & Training Center near Corbin, VA. This location may change.
 - 3. UESI will be sending a proposal to FIG, applying for membership. AAGS will provide a letter of support, as discussed at the May 14 meeting.
 - 4. Gillins will talk with Michael Dennis about other groups aiming for FIG membership.
