Board of Directors Monthly Meeting Minutes Wednesday, December 08, 2021

# I. Open meeting, President

- A. The Board of Directors meeting was called to order by AAGS President Dave Zilkoski at 16:19.
- B. AAGS President Dave Zilkoski also called the roll.

- 3. At least two directors were present as well as a quorum; therefore, the meeting was authorized.
- II. Agenda

A. Upon a call for additions, the AAGS BOD agenda was accepted as distributed December 08.

III. Minutes

A. The November 10 AAGS Board Meeting Minutes final draft was accepted as distributed November 16.

- IV. Review of Last Month's Action Items and Important Business
  - A. Membership committee's recommendation to extend the Board meeting by 30 minutes to include a short presentation by an AAGS member (Martin).
    - 1. The meeting extension for presentation is to be scheduled quarterly (rather than monthly), to gauge interest, starting February 2022.
    - 2. The initial 30-minute presentation will be about what geodesy will look like in the next ten years.
    - 3. 30-minute presentations will be free to AAGS members, charge a fee to non-members, and free once or twice to NSPS members.
    - 4. All are welcome, but individuals wanting to hear the presentation should request to be invited, so that AAGS has their contact info, to send membership applications thereafter.

- 5. Speakers invited to present include Dan Gillins, Dru Smith, Dan Roman.
- 6. Action Item: The Membership Subcommittee for Communications will work together to compile a list of topics and presenters for the Board's review and comment.
- B. Zilkoski talked to GeoLearn's Joe Paiva, who stated that he is interested in partnering with AAGS to develop videos for AAGS members.
  - 1. Paiva will charge for video production, but provide whole system and processing.
  - 2. Cavell asked whether GeoLearn would also use AAGS-produced content.
- C. AMERICAN ASSOCIATION FOR GEODETIC SURVEYING INC trademark registration (Roman).
  - 1. Action Item: Zilkoski will check whether anything needs to be done to maintain AAGS trademark registration.
- D. AAGS can become a formal sponsor of the UESI Surveying and Geomatics Conference 2022 (Meyer)
  - 1. The AAGS Board previously passed a motion to sponsor the UESI Surveying and Geomatics Conference 2022 at the silver level (\$2500. See November Board Meeting Minutes.
  - 2. No further updates.
- E. AAGS active participation to support UESI 2023 as a joint event with FIG Working Week 2023 in Orlando, Florida. (Zilkoski)
  - 1. Zilkoski talked to John Hohol about getting AAGS involved with the working week. The discussion included AAGS members organizing sessions and presentations, members staffing an AAGS booth, and AAGS website and newsletters advertising the working week.
  - 2. Zilkoski recommended setting up a time to discuss with Hohol. Heck counter suggested that Hohol be invited to a Board meeting. Cavell and Heck will meet soon by phone.

3. Cavell recommended that certification be awardable on the basis of exam score, without requiring participation in a specific course.

    - NSPS mgmt changes in January 2022, as Curt Sumner hands the reins to a new leader an opportunity for AAGS to make a good new beginning.
